Amphitheater Public Schools Foundation, Inc.

The TRCF grant monies will be used in critical areas of need which include classroom technology, the Amphi Clothing Bank & Resource Center, Math PLUS Tutoring, athletic fee waivers, academic competition travel assistance, summer basketball camps, and classroom mini-grants.

This year ATC celebrates its 50th Anniversary, providing our community with exceptional theatrical entertainment and artistry. The TRCF grant will support the purchase of a state of the art wireless microphone packages for Summer on Stage and Summer Backstage, a five-week youth intensive training program in performance and technical theater. The coaching and preparation culminate in fully realized productions performed on the main stage of the Temple of Music and Art.

Mobile Meals of Tucson, Inc.

Mobile Meals of Tucson serves freshly-prepared, medically-tailored meals to homebound adults of all ages who suffer from debilitating chronic illness. With the mission of preserving the health and independence of homebound adults, Mobile Meals of Tucson is celebrating 46 years of service to Tucson, as well as Sahuarita and Green Valley.
