1. Pick up an application from Tucson Association of REALTORS® ahead of time OR complete the application at the event.
 - For efficiency, please fill out the application ahead of your appointment time.
2. Complete the application using blue or black ink only. DPS will reject other colors.
 - All required boxes are marked with a star.
3. Please *DO NOT* separate the pages.
 - The bar code on your application will match the second page's number for the Arizona Livescan team to use during your appointment.
 - You must have both pages with you at your appointment.

5. All payments for DPS and Arizona Livescan will be made during the appointment.
 - **Cost:** \$109 (includes \$67 DPS fee + \$32 Arizona Livescan fee for fingerprint rolling/postage/handling and submission).
 - **Acceptable Payment Types:** Cash, debit, or credit (NO personal checks. Business checks are acceptable if payable to Arizona Livescan and for the correct amount).
6. Bring a valid/unexpired photo ID to your appointment.
 - Please review the attached document for acceptable types of photo ID's.

Pre-Service Non-IVP

Online AZDPS Application

If you selected the Pre-Service Option for the Fingerprint Clearance Card One-Stop event, please review the following instructions and notes to ensure you are ready for your scheduled appointment slot.

1. Select the link below to complete the online application ahead of your scheduled appointment slot.
 - Click the link to get started: [AZDPS FCC Form](#) or scan the QR code below.
2. Pay the \$67 DPS fee while filling out the online application.
 - via debit/credit
3. Once completed, you will receive a **Reference #** beginning with “P”.
 - **You MUST bring this number to your appointment time slot.** This will be written on your fingerprints before submission to DPS.
4. While attending your appointment at TAR, you will pay Arizona Livescan \$32.
 - This is the fee for fingerprint capture and postage which is separate from the DPS fee.
 - **Acceptable Payment Types:** Cash, debit, or credit (NO personal checks. Business checks are acceptable if payable to Arizona Livescan and for the correct amount).

Identification Requirements

Primary forms of identification must be issued by a government agency, unexpired and the photograph must reasonably resemble the applicant's physical appearance.

Primary forms of identification may include any of the following:

- Any US state-issued Driver's License
- Any US state Issued Identification Card
- U.S. Passport
- U.S Military Identification Card
- Employment Authorization Card (Work Visa) or I-766
- Consular Identification Card (In Mexico, known as the Matricula Consular)

If a primary form of identification is unavailable, two or more secondary forms of identification may be accepted ***so long as the combination of documents verify the applicant's name, date of birth, include a photograph and are unexpired.***

Secondary forms of identification include any of the following:

- State government issued Certificate of Birth
- Federal government Personal Identity Verification Card (PIV)
- Department of Defense Common Access Card
- U.S. Tribal or Bureau of Indian Affairs Identification Card
- Social Security Card
- Court Order for Name Change/Gender Change/Adoption/Divorce
- Marriage Certificate (Government issued certificate)
- U.S. Government issued Consular Report of Birth Abroad 3
- Foreign passport
- Certificate of Citizenship (N560)
- Certificate of Naturalization (N550)
- Utility bill (address)
- Jurisdictional voter registration card
- Vehicle registration card/title
- Paycheck stub with name/address
- Cancelled check or bank statement
- Mortgage documents with name/address
