Broker Renewal Requirements

What you need to renew:

- ✓ 30-33 Hours of ADRE-Approved CE
- ✓ Valid Fingerprint Clearance Card (FCC)
- ✓ Completed License Renewal Application
(includes Disciplinary Action Disclosure Form)
- ✓ Copy of DL or other Government ID
- ✓ Submit renewal through ADRE

Important Notes

- CE must be completed **before license expiration**
- Fingerprint Clearance Card must be **current** *(valid for 6 years)*
- Submit renewal **on or before your expiration date**
- You are eligible to apply for renewal **90 days** prior to your expiration date
- **Save your CE certificates** both electronically and physically
