Nationwide

In many states, real estate was protected as an essential service during the COVID pandemic.

- The National Association of REALTORS® worked across state lines and with federal agencies to protect real estate as an essential service, keeping transactions moving during lockdowns.
- There were 6.5 million homes sold in the U.S. in 2021. At an average of 10 residential sides per REALTOR® that resulted in an average of \$43,330 in commissions was saved.

Locally

No renter's tax.

- A 2% tax on renters was proposed in 2009 and again in 2011. Our advocacy efforts helped oppose it both times.
- At an annual rental rate of \$15,000, renters saved an additional \$300.

Tucson Association of REALTORS® fought to keep housing providers and tenants together.

- Home and Property Advocates invested countless hours during the eviction moratorium assisting housing providers and tenants in receiving aid from the state and federal governments.
- Pima County distributed a greater percentage of the available funds to those in need than any other county in Arizona.

Tucson Association of REALTORS® fights for your business, your clients, and our communities.

- We fight against burdensome regulations that affect property rights and zoning ordinances.
- We advocate for your ability to conduct business by opposing oppressive regulations, sign ordinances, and taxes.
- We promote the need for good infrastructure, roads and parks, and safe communities.

Statewide

REALTORS® and real estate professionals are not taxed on their services in Arizona and saved 5.6% in revenue.


- Arizona Proposition 126 prohibits state and local governments from enacting new taxes, or increasing tax rates, on services performed in the state.
- For every \$10,000 in commissions, REALTORS® saved an additional \$560.

No transfer tax - sellers save up to 2.2%.

- Arizona Proposition 100 created to oppose a 2.2% real estate transfer tax, prohibits the government from charging any new tax on the sale or transfer of real property in Arizona.
- With Tucson home sales prices averaging \$328,00 in 2020, the transfer tax could have cost sellers an additional \$7,216.

How Do We Advocate?

Local and state associations help the REALTOR® Party achieve its advocacy goals by engaging in the Vote, Act, and Invest activities.

- Act participate in member mobilization efforts, build relationships with elected officials, and share our voice in calls for action.
